Avila says in the Fire Chief's Report "Our apparatus committee has since morphed from an engine committee into a water tender committee in efforts of pursuing options for a water tender replacement at the Boonville Station. With the savings now available in the apparatus reserve account of approximately \$200,000, I am now aiming to replace the second apparatus on the replacement list. A replacement tender will put an efficient water tender in the center of the district and will allow an existing water tender to become available in Yorkville. The east end of the district will likely be needing a water tender in that area to keep ISO in the near future and will assist serving that end of the Valley." Motion by McKenna to re-direct the \$200,000 of the appropriated funds originally intended for the fire engine and use them to purchase a new water tender. 2nd by Clark. All ayes, no nays.
